WHEREAS, the institution Thirumal College of Eduction, Thirumalnagar, Pallalapalli, Lakkinaikanpatti Post, Tirupattur, Vellore-635601, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/14188 dt. 06.11.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 2. submitted affidavit dt. 12.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.
- AND WHEREAS, a provisional revised recognition order was issued to the institution 3. on 01.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, the matter was placed before the SRC in its 374th meeting held on 09th & 10th April, 2019 and considered the matter and decided to issue Show Cause Notice. Accordingly as per the decision of SRC a Show Cause Notice was issued to the institution on dt. 15.04.2019. The institution vide letter dated 25.04.2019 submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 384th meeting held on 12th 13th February, 2020 5. considered the matter and decided to issue Final Show Cause Notice. Accordingly as per the decision of SRC a Final Show Cause Notice was issued to the institution on 05.03.2020. The institution vide letter dated 23.05.2020 submitted reply to the alongwith land & building documents having address as S.F. No. 282/1, 282/2A2, 282/2B, 282/13, Pallalapalli Village, Lakkinayakkanpatti Panchayat, Tirupattur Taluk, Tirupattur District, Tamilnadu and staff list etc.
- AND WHEREAS, the SRC in its 387th meeting held on 24th 25th August, 2020 considered the matter and decided as under:-

"The original files of the Institution along with other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution vide letter dt 12.08.2020, Committee decided that the continuation order be issued to the Institution Thirumal College of Education, Thirumalnagar, Pallalapalli, Lakkinaikanpatti

- 7. NOW THEREFORE, the SRC decided to permit the institution i.e. Thirumal College of Education, S.F. No. 282/1, 282/2A2, 282/2B, 282/13, Pallalapalli Village, Lakkinayakkanpatti Panchayat, Tirupattur Taluk, Tirupattur District, Tamilnadu for B.Ed. course run by Thirumathi Rajamma Perumal Educational & Charitable Trust, Vellore District, Tamilnadu for continuation of recognition for B.Ed. course of two-years duration with an intake of 100 students (two units) subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and pon-teaching staff with photographs, for information of all concerned. - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and 11. display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 12.
- The institution shall fill the information on GIS Portal on the NCTE Website. 13.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules. Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
